

Lease Statistics (FY 2006)

◆ Outline

The total lease transaction volume in FY 2006 is 7,867.7 billion yen, decreased by 0.9%, compared with the volume in FY 2005 <corporations researched : 258>.

Leasing percentage to total private capital investment is 8.82% and this indicates that approximate 9% of the private capital investment is occupied by lease.

In detail of the lease transaction volume, with respect to type of equipment, Factory Equipment has kept growing steadily in a row of four years, while Information and Communication Equipment has marked negative growth in a row of two years. In regard to type of Lessee's size, the volume of "Small and Medium sized Companies" has risen in a row of three years and that of "Large Companies" has turned to decrease. In regard with type of Business, "Manufacturing Sector" has changed to negative growth and "Non-Manufacturing Sector" has marked increase in a row of four years.

◆ Leasing Percentage

Leasing Percentage (ratio of leasing capital investment to the total private capital investment) in FY 2006 is 8.82%, which indicates a slight reduction. Lease, however, plays a role of approximate 9 % of the total private capital investment.

◆ Lease Transaction Volume by Type of Equipment

Factory Equipment (14.4% up) has showed double-digit increase in row of four years since FY 2003. Industrial Equipment (4.2% up) and Office Equipment (0.7% up) have been on the increase in a row of two years and Construction Equipment (11.7% up) has also changed to positive growth. On the other hand, Information and Communication Equipment (4.9% down) has been on the decrease in a row of two years due to that Computer Hardware (7.9% down) and Telecommunication Equipment (13.5% down) have kept on decreasing, although Computer Software (11.2% up) has showed double-digit increase. Medical Equipment (0.9% down), and Commercial and Service Equipment (3.9% down) have turned to negative growth respectively.

◆ Lease Transaction Volume by Size of Lessee and Lessee's Business Type


"Small and Medium Sized Companies" (companies with capital 0.1 billion yen and less or solo proprietors) marked positive growth in a row of three years (2.1% up), and "Large Companies" (companies with capital over 0.1 billion yen) turned to negative growth (3.8% down). The component ratio of "Small and Medium Sized Companies" is 50.2%, and that of "Large Companies" is 44.6%. The share of "Small and Medium Sized Companies" has exceeded that of "Large Companies" in a row of three years.

"Non-Manufacturing Sector" (1.4% up) has been on the increase in a row of four years, while "Manufacturing Sector" (4.0% down) has turned to negative growth. With regard to "Non-Manufacturing Sector", "Real estate" (4.5% up) and "Wholesale and Retail" (1.4% up) have been on the increase in a row of two years, whereas "Information and Communications" (3.7 % down), "Transport" (2.1% down), "Restaurant, Lodging" (1.0% down) and "Medical and Welfare Service" (4.9% down) have turned to negative growth respectively. Each of "Manufacturing Sector" has generally showed negative growth.

Lease Statistics (April 2007)

Lease transaction volume in April 2007 is 654.6 billion yen, decreased by 3.9%. It is the first time since last November that the volume has turned to negative growth. Construction Equipment (23.4% up), Factory Equipment (11.6% up) and Industrial Equipment (10.9% up) have highly increased, while Medical Equipment (20.4% down), Information and Communication Equipment (5.4% down), Commercial and Service Equipment (5.1% down) and Office Equipment (0.2% down) have decreased.


Trends in Lease Transaction Volume, Leasing Capital Investment and Leasing Percentage to Total Private Capital Investment



Lease Transaction Volume by Type of Equipment - Yearly Change (%)




Lease Transaction Volume by Size of Lessee - Yearly Change (%)
