

Lease Statistics (The First Half of FY2008)

The lease transaction volume in the first half of FY 2008 (from April 2008 to September 2008) is 3,109.1 billion yen, decreased by 13.9% compared with the same period of the previous year.

With respect to the type of equipment, Construction Equipment (0.04% up) has turned to positive growth on a half year basis.

On the other hand, Information and Communication Equipment (8.8% down) has been decreasing since the second half of FY2005 on a half year basis. Industrial Equipment (19.2% down), Factory Equipment (18.2% down), and Transport Equipment (9.6% down) have been respectively decreasing since the first half of FY2007 on a half year basis. Office Equipment (17.6% down), Medical Equipment (10.9% down), and Commercial and Service Equipment (21.3% down) have been also on the decrease.

The lease transaction volume in September 2008 is 633.7 billion yen, decreased by 10.9% compared with the same period of the previous year. The volume has been decreasing in a row of 16 months since June in 2007. With respect to the type of equipment, Transport Equipment (7.7% up) has turned to positive growth. On the other hand, Information and Communication Equipment (4.3% down), Office Equipment (14.8% down), Industrial Equipment (14.6% down), Factory Equipment (22.4% down), Construction Equipment (1.0% down), Medical Equipment (18.3% down), and Commercial and Service Equipment (19.8% down) have showed negative growth respectively.




