

## **Lease Statistics (FY 2010)**

### ◆ **Outline**

The total lease transaction volume in FY 2010 is 4,555.3 billion yen, decreased by 7.2%, compared with the volume in FY 2009 <corporations researched: 233>.

Leasing percentage to total private capital investment is 6.24%, and this indicates that leasing plays a role of approximate 6% of the total private capital investment.

With respect to type of equipment, Office Equipment has showed a slight increase. However, Information and Communication Equipment, Industrial Equipment, Transport Equipment, and Commercial and Service Equipment have continuously showed negative growth respectively. In regard to type of lessee's size, "Small and Medium sized Companies" has turned to positive growth, while "Large Companies" has continuously decreased. In regard to type of lessee's business, both "Manufacturing" and "Non-Manufacturing" have decreased.

### ◆ **Leasing Percentage**

Leasing Percentage (ratio of leasing capital investment to the total private capital investment) in FY 2010 is 6.24%, and leasing plays a role of approximate 6% of the total private capital investment.

### ◆ **Lease Transaction Volume by Type of Equipment**

It is the first time since FY2007 that Office Equipment (0.5% up) shows positive growth on a fiscal year basis. On the other hand, Information and Communication Equipment (3.0% down) has showed negative growth in a row of 6 years since FY2005 although Computer Hardware (1.5% up) and Telecommunication Equipment (1.7% up) have respectively increased. In addition, Medical Equipment (3.2% down), and Commercial and Service Equipment (6.0% down) have respectively showed negative growth in a row of 5 years. Other equipment, such as Industrial Equipment (25.2% down), Factory Equipment (4.8% down), Construction Equipment (12.7% down) and Transport Equipment (0.8% down) have been on the decrease.

### ◆ **Lease Transaction Volume by Size of Lessee and Lessee's Business Type**


It is the first time since FY 2007 that "Small and Medium Sized Companies" (companies with capital 0.1 billion yen and less or solo proprietors) shows positive growth (1.9% up), while "Large Companies" (companies with capital over 0.1 billion yen) has showed negative growth (17.4% down) in a row of 5 years. The component ratio of "Small and Medium Sized Companies" is 47.0%, and that of "Large Companies" is 44.6%.

"Non-Manufacturing" (5.3% down) has showed negative growth in a row of 4 years, while "Manufacturing" (14.2% down) has also showed negative growth in a row of 5 years.

### **Lease Statistics (April 2011)**

Lease transaction volume in April 2011 is 422.5 billion yen, increased by 1.0%. With respect to the type of equipment, Industrial Equipment (60.5% up), as well as Factory Equipment (16.7% up), has sharply increased. The other equipment, such as Information and Communication Equipment (7.7% down), Office Equipment (5.1% down), Transport Equipment (15.0% down), Medical Equipment (12.5% down) and Commercial and Service Equipment (3.8% down) have respectively showed negative growth.


**Trends in Lease Transaction Volume, Leasing Capital Investment and Leasing Percentage to Total Private Capital Investment**



# Lease Transaction Volume by Type of Equipment - Yearly Change (%)




**Lease Transaction Volume by Size of Lessee - Yearly Change (%)**
